Bay Area Expanded Logistics and Critical Lifelines Project: Peter Ohtaki and Lee Rosenberg gave an update on Critical Lifelines stakeholder meetings and continuing Logistics and Restoration of Critical Lifelines work. The project timeframe was updated and anticipated project completion is slated for the end of February 2014. A discussion was conducted about conflicting terminology used in the Logistics Plan companion materials with different agencies.

Med/Surge & Patient Tracking: Eric Shanks was introduced to the RCPT as the interim project manager for Goal 5, Public and Medical Health. Eric will lead the Medical Surge and Patient Tracking Project. He announced the Med Surge Project gap analysis has reached 75% completion. It was also announced that ICF would be conducting the Gap & Capabilities Analysis on Dec 11th, and a final report would be given to the Approval Authority at the Dec 12th meeting. Amy Ramirez questioned who would participate in the meeting, and Mr. Shanks announced that he would contact the appropriate attendees for the meeting via email.

RCPGP Sustainment Plan: Mary Landers reported out on the status of the RCPGP Sustainment Plan. She presented the Puget Sound RCPT Sustainment Plan to showcase the organization, content and format expected of the Bay Area's Sustainment Plan. An opportunity for feedback and review would be presented upon receipt of the Sustainment Plan draft from URS.

Recovery Project Planning Review: Janell Myhre reviewed project concepts and gathered RCPT input for future work. The Bay Area Recovery Planning Survey was presented updating stakeholders with current status of Bay Area local government Recovery work surveyed in June 2013. A call for a steering committee was placed to allocate 245K in UASI FY13 funding for recovery. Approval Authority approved Project Scope ideas included updating debris removal plans, crafting coop/cog standards and templates to assist operational areas and core cities who have not prepared pre disaster planning, and to begin the national disaster recovery framework plans from core cities.

MISC

JIC/JIS- Janell Myhre announced that Kristen Hogan and San Francisco DEM are working with a vendor Nusura on a JIC/JIS called Simulation deck, which will be tested during an Urban Shield exercise on 10/25.

A reminder was given by Janell Myhre about the upcoming DMORT and FAC demonstration on October 26th.

Janell Myhre also announced that the RCPGP Table Top exercises After Action Report was due by the end of November.

Janell Myhre called for FY11 and FY12 to be submitted to the UASI for work completed, and that FY13 MOUs were under way. She also announced that FY14 project proposals are due November 15th, 2013.
