May 2013 Meeting Minutes (RCPGP Full Scale & Functional Exercise MPM Meeting)

I. General

Jim Bailey (Willdan) facilitated the Midterm Planning Meeting (MPM) for the 2013 Urban Shield Functional Exercise (FE), in alignment with the updated Homeland Security Exercise Evaluation Program (HSEEP). The MPM agenda included planning updates, exercise design elements, and exercise development elements.

II. Initial Planning Meeting (IPM) Minutes Review

Meeting participants did not request updates or revisions from the IMP Minutes.

III. Planning Updates

The following jurisdictions are participating in the FE:

- San Mateo County Emergency Operations Center (EOC) and Coroner
- The City and County of San Francisco (CCSF) EOC and Medical Examiner (to be determined)
- Contra Costa County EOC and Coroner
- Alameda County Coroner

Disaster Mortuary Operational Response Team (DMORT) Field Unit Demonstration

- The DMORT demonstration on October 26, 2013 is open to all Region 2 coroners.
- The American Red Cross (ARC) will participate and the DMORT, which will include a Family Assistance Center (FAC).
- Google, Inc. has the capability to track missing persons via social media the group will contact Google to see if they would like to participate in the DMORT.

IV. Exercise Design

Design Elements

• All FE and DMORT parking will be included in the ExPlan.

- Each EOC will be conducting separate and isolated exercises.
- Many of the participating jurisdictions are currently updating their plans, or their plans are incomplete. Since the FE requires a plan to measure the FE results, each participating jurisdiction should send their latest plans that they would like to exercise to Lani Kent by May 31, 2013. URS/Willdan will note that the plans being exercised are not yet final in the final materials.
- First train accident (Emeryville) will be a simulated terrorist event; second train accident (Contra Costa County) will be a result of a switching error, not a terrorist attack.
- The group will have the opportunity to review the ExPlan "line by line" at the Final Planning Meeting (FPM).
- The REOC will be simulated.
- EOCs usually do their own internal badging, since it is part of EOC activation.

Duration and Venue

• The length of time that each EOC will activate may vary. Participating agencies are asked to send Ms. Kent their duration of play so that the exercise and injects can be planned accordingly.

V. Exercise Development

Logistical Arrangements

- Mr. Bailey requested that each participating EOC email Ms. Kent the EOC position phone numbers for the communications list by May 31, 2013.
- Each EOC will provide parking and transportation information for the ExPlan.
- Simulation Cell (SimCell): URS will provide simulators, but it would be beneficial if representatives from the yellow command or other agencies participate as well. Sonoma County and the city of San Jose have offered to staff the SimCell.
- The SimCell is currently planned to be at Alameda Office of Emergency Services (OES); however, this location may not be ideal due to limitations on rooms with enough phone lines. An alternative location may better serve as the SimCell. Contra Costa County will check for alternative facilities within their jurisdiction that can serve as the SimCell.

Exercise Support Schedule

- The Controller/Evaluator Briefing will take place week of October 21, 2013.
- Volunteer registration will occur on Friday, October 25, 2013.
- The FE will have a hot start at 8 a.m., when the train accident will occur.
- The FE will have a hard end time at noon (for mass fatality events). SimCell could stay active to support CCSF if San Francisco would like to play longer.
- San Mateo County will activate for at least two hours, but they may extend to four hours.
- Contra Costa County will activate for approximately four hours.
- The CCSF will activate between four and six hours.

Exercise Planning Timeline

• The group rescheduled the After Action Meeting (AAM) for the Thursday prior to Thanksgiving week (November 21, 2013).

The meeting adjourned at 12 p.m. The next meeting will be the MSEL Meeting on August 29, 2013 at the Alameda County OES.
