### **Meeting Minutes**

### I. WELCOME & INTRODUCTIONS

Commander Dennis Houghtelling welcomed meeting participants and requested participants to introduce themselves.

### II. REGIONAL TRAINING & EXERCISE PROGRAM Dennis Houghtelling

### A. <u>PROGRAM UPDATE</u>:

Commander Dennis Houghtelling asked if any participants had proposal issues and encouraged members to contact him if there were any questions.

Commander Dennis Houghtelling reported the vendor contact is in the process of being signed and the MOU is being presented to the Board of Supervisors for adoption. Several new vendors will enhance the training program.

Commander Dennis Houghtelling reported Multi-Year Training and Exercise Plan is due to expire in 2015. Commander Houghtelling reported the tentative dates for the RTIPP course are April 21 and 22, 2015, and asked participants to save the date. Commander Houghtelling encouraged participants to send a representative if they were unable to attend with the information to be incorporated into the plan. Commander Houghtelling reiterated the importance of completing the plan because without it the region is not eligible for funding from Department of Homeland Security. LSU will conduct the RTIPP class/workshop and the T&E team will draft the new plan.

Commander Houghtelling reported there will be Vendor Day early in 2015.



### B. <u>CSTI PRESENTATION</u>:

Mike Brady from CSTI presented a PowerPoint highlighting CTSI Training and Exercise course offerings and objectives that include State EOC Credentialing program status, Emergency Management Certified Outreach, updated and new courses, specialist programs, and FEMA Advanced Professional Series.

# A. FY-15 GRANT UPDATE/COMMENTS

Project Manager Bruce Martin reported the FY-15 grant process closed on October 31, 2014, and UASI staff members are currently vetting the proposals and ensuring compliance. Commander Houghtelling commented participants might be asked for clarification of proposals.

Bruce Martin (UASI CBRNE Project Manager) reported PRND is transitioning from development to sustainability and will become a line item at future CBRNE meetings. Project Manager Bruce Martin shared there will be a meeting in early 2015 to discuss special events.

Bruce Martin presented a PowerPoint on PRND strategy, purpose, concept of operations, grant proposal update, training, and special events (Super Bowl at Levi Stadium in 2016). The documents will be available on the NCRIC website and the UASI website as appropriate.
